Biographies



Mohammed Alam Begi

Mohammed is a Research Associate at FED and a Consultant at the City of London Corporation's Education Strategy Unit. He was born and grew up during the heart of the war that has troubled Afghanistan for decades. Mohammed left Afghanistan and arrived in the UK, where his life and prospects quickly changed when he started attending school. Mohammed hopes that his story will inspire young people to remain resilient. He was appointed to the Student Advisory Board Member at Social Mobility Foundation. He remains optimistic and advocates for young people to realize their dreams and ambitions through education.



Tom was formerly Chief Executive of George Spencer Foundation School and Technology College in Nottingham during which time the school received consecutive 'outstanding' Ofsted reports.

Under Tom's leadership the school became the first 'grant maintained school' in Nottinghamshire; one of the first 13 'specialist technology colleges' in the country; one of the first 'Beacon Schools' in the country and the first 'federated' school in Nottinghamshire- a forerunner to a MAT.

For 3 years Tom was Associate Director of the Specialist Schools and Academies Trust (SSAT)

- He led for the Trust on workforce-remodelling
- Working with the DfE Tom published booklets on 'study leave', 'benchmarking and financial planning', and 'workforce reform'.
- Tom helped create the 'Raising Achievement Transforming Learning' project for the SSAT working with the DfE.
- Working with Professors Hopkins, Hargreaves, Harris, and Jessen he helped develop international school networks in Australia, The United States and Hong Kong providing CPD to support Deputy Headteachers who were preparing for Headship.





For 10 years Tom was a Trustee of the West Bromwich Albion Football Club Community Programme

For 6 years Tom was Chairman of FASNA (Freedom and Autonomy for Schools – National Association) and advised successive Secretaries of State on policy matters and contributed to publications on governance and on effective financial management in schools

- During this time, Tom undertook over 100 roadshows for the DfE, showcasing academy status, the formation and growth of MATs, and financial management.
- At the invitation of 2 secretaries of State, Tom served on 2 'special advisory boards' one relating to the role of Local Authorities and the other on school funding
- Tom worked with the DfE team on the development of the new National Fair Funding model.

Tom was appointed Chair of the IEB Members and Vice Chair of the IEB for an academy in Derbyshire, which was in difficulties.

For 5 years Tom chaired Govnet's Advisory Education Board helping to re-shape their Schools and Academies (biannual) Shows and bringing an international dynamic to these events.

Presently Tom is Vice Chair of Academy Transformation Trust which has 21 academies and he is an Ambassador for The Foundation for Education Development



Rosie Clayton

Rosie is an education specialist working on leading projects and initiatives spanning education, skills, technology and lifelong learning. Her work bridges policy and practice, systems thinking and social change. She is currently a Research Fellow with the World Innovation Summit for Education, project lead for the Rethinking Assessment movement, and working on the Fusion Cities initiative led by the City of London. Rosie was previously an Associate Director at the Royal Society of Arts, Manufacturers and Commerce leading the Cities of Learning programme the UK, and worked for Big Change on strategy and impact. She is one of the Co-Founders of the Weaving Lab, which is developing global expertise in the field of learning ecosystems.



Eugene Dapper

Eugene consults with organisations domestically on strategy, leadership and teacher recruitment and retention. Alongside his work at the FED, Eugene is currently the Independent Chair for the Norfolk Commissioning Hub, a strategic partnership, co-ordinating groups of stakeholders across Norfolk to support school improvement.

Eugene recently served as the Lead Researcher and Project Manager for the WISE-funded Securing the 21st Century Teacher Workforce Project. A FED council member, Jason's early career centred around internet innovation – leading some of the most progressive early 'dotcoms' – before turning his heart to education.

Jason has acted as a critical friend to many educational institutions and some of the world's largest companies in their educational engagement strategies. Within the education sector, Jason is best known for leading a global cultural exchange programme, which supported over 200,000 children from over 3,000 classrooms across the Globe, founding Pop-Up College in partnership with Costa Coffee, and more recently, in scaling the renowned social mobility charity Speakers for Schools throughout the challenges of Covid-19.

Speakers for Schools was founded in 2010 by ITV's Political Editor Robert Peston, and has been supported by the Law Family Charitable Foundation for almost a decade. Its mission is to level the playing field for young people, by giving access to the same networks as the top fee-paying schools. Speakers for Schools has supported schools with talks from over two thousand societal leaders (including PMs, Ministers, Industry leaders, Actors, Artists, Scientists and Sports professionals) to 1.2mm young people and experiences of the workplace to approaching 100,000 young people in partnership with 800 employers (including Google, Spotify, Industrial Light & Magic and Bentley).

Cambridge-educated, Jason undertook an Honours Degree in Economics, Masters in Retail Management, Postgraduate Certificate in Education, and most recently Masters in Education, focusing on Educational Leadership and School Improvement.



Alastair Falk

Alastair's career has encompassed three Headships; work on education strategy at a local and national level and setting up of new education organisations. His first Headship was a single form entry primary, after which he moved to become the founding Head of a new secondary school in North East London, before becoming Principal of one of the first Academies, an all age school that included primary, secondary and SEN provision. He has also worked as Director of the Reed Foundation's Academy of Enterprise, where he designed the first national GCSE level qualification in Enterprise Capabilities, Director of Educational Leadership for a national education charity and CEO of the Birmingham Education Partnership. His role in FED includes developing the online FEDspace events and the programme for the FED summits.


