Professor Nazila Ghanea

Nazila assumed her mandate as Special Rapporteur on freedom of religion or belief on 1 August 2022.

Nazila is Professor of International Human Rights Law and Director of the MSc in International Human Rights Law at the University of Oxford. Prior to that, she was Senior Lecturer at the University of London (2000-2006), and she has also previously taught in the People's Republic of China (1993-1994). She has researched and published widely in international human rights law and served as consultant to numerous agencies.

Though her nearly 30-year career has been rooted in academia, Nazila's academic work has often connected with multilateral practice in international human rights law. She has contributed actively to networks interested in freedom of religion or belief and its interrelationship with other human rights, and advised states and other stakeholders. In her professional activities, she has taken every opportunity to support the promotion and application of principled understandings of human rights, including freedom of religion or belief. She has supervised well over 100 master's dissertations and doctorates and served on doctoral panels internationally. She has also co-authored a 700-page publication by Oxford University Press that addresses freedom of religion or belief and is focused on the UN record.



Rabbi Alex Goldberg

Alex is a barrister, human rights activist and Dean of Religious Life and Belief at Surrey University. He is working in conjunction with the UN on its Faith4Rights programme. He served as founding co-chair of Faith Forum for London and founded René Cassin human rights group. Alex is the Football Association's Faith Group chair and an Olympic Games Chaplain. He is advised the UK Government and US State Department on education and community relations issues. In 2022, he was named an Interfaith Associate of Guildford Cathedral and an honorary member of their College.
