Lady Emma Barnard

Lady Emma Barnard is the Lord-Lieutenant of West Sussex and was appointed in 2022.

Lady Emma was brought up in Ireland. She read English Language and Literature at Lincoln College, Oxford, and took an M.Phil in Shakespeare and Early English Drama. Since 1994 she has lived at Parham House, near Pulborough, an Elizabethan house with awardwinning gardens owned by a charitable trust. She is Chairman of Parham Park Ltd, which maintains Parham and opens it to the public.

Lady Emma was High Sheriff of West Sussex in 2017-2018. She became a Deputy Lieutenant in 2019.

Lady Emma is a Patron of the British Evacuees Association and the Coroner's Court Support Service. In June 2022 she came to the end of a six-year term as Chair of the Patrons of the National Gallery, London. She is a trustee for a college fund of Lincoln College, Oxford.

In West Sussex, she is an Ambassador for the Sussex Community Foundation and President of the Mary How Trust. Other organisations she supports include the West Sussex Ambulance Retirement Association, The Association of Sussex Artists and Kamelia Kids Day Nursery.

Lady Emma's husband James is a barrister, and they have two adult sons.



Colonel Edward Bolitho OBE

Edward was born in Penzance and, after school and university, joined the Army, serving with Grenadier Guards for 20 years throughout the world. He left the Army in 1998 to return to Cornwall. Since then he has run the family businesses; principally based in West Cornwall, this involves farming, property rental, building renovation and conversion and management of leisure activities.

He was appointed Lord-Lieutenant of Cornwall on 19 September 2011 and Chairman of the Association of Lord-Lieutenants in 2018. He is married to Alexandra and they have twin daughters, one son and two granddchildren.

David is married with three daughters and three grandchildren aged 3 to 18 and lives in Aberdeen.

His employment included being a Technical Assistant at Unilever Research; Technical Manager with Lawson of Dyce and a Lecturer, Senior Lecturer, Deputy Head of School and Acting Head of School at the now RGU before setting up Cameron Food Safety Ltd in 1990.

Bill is Dundee's Lord Provost. He represents the West End ward as a Scottish National Party (SNP) Councillor.

Mr Ian Crowe MBE

lan is a local businessman, recently retired. He was awarded an MBE in the Queen's Birthday 2019 Honours List for his committed service to the community of Northern Ireland, having chaired numerous organisations such as Air Ambulance NI Charity (AANI), Past President of the Londonderry Chamber of Commerce, City of Derry Rugby Club and others in a voluntary capacity over the last forty years.

Ian has lived and worked in Northern Ireland since the beginning of his career, married to Christine and they have two adult children. Ian's first leadership role was Captain of City of Derry Rugby 1st XV in 1978 a position he held for four years. Ian also represented Ulster between 1978 to 1985. Patrick spent 20 years in the Grenadier Guards (1969-87), investment banker with Robert Fleming & Co (1988-2000), CEO of RFIB Group from 2000-2009, three City NEDs until 2016.

Appointed Lord-Lieutenant of Worcestershire in 2012. President or Patron of a number of charities and voluntary organisations in the County, including Worcester Cathedral, the Worcestershire Bench of the Magistrates Association and Chairman of the West Midlands RFCA.

Trustee/advisor to a number of voluntary/charitable organisations including The Lloyds Patriotic Fund, The Nuffield Trust for the Forces of the Crown, The Grenadier Guards, The Hedley Foundation and the Royal Military Academy Sandhurst.

Mohammed is His Majesty's Lord-Lieutenant of the County of Somerset. Prior to this he has held several executive roles spanning over thirty years in the utilities and renewable energy sectors.

Mohammed is passionate about the environment and sustainability and his work has been recognised globally for the positive impact it has had on society through the Institute of Chemical Engineers Global Award for Sustainability and the Guardian Sustainable Business Award in 2017. He was awarded the Honorary Degree of Doctor of Science from the University of the West of England in recognition for enhancing the sustainable development of Bristol.

He is the owner of an agricultural estate, complete with an historic house and domestic and commercial lettings. He trained as a chartered surveyor which has helped him manage the estate. In this he is ably assisted by his wife Deborah who also supervises the opening of the snowdrop garden and various theatrical and filming events.

He subsequently served as a Council member of The Duchy of Lancaster, including nine years as its chairman. He was chairman of the Association of Lord-Lieutenants for ten years from 2008.
